## **Family Engagement:**

- **Communication:** respectful, 2-way communication; multiple ways to communicate, time made to engage families in meaningful conversation.
- **Family Needs and Feedback:** family input guides program planning & policies; program is adapted to meet the needs of children & families; hiring practices reflect families' diverse backgrounds.
- **Collaborative Activities with Families**: families are encouraged to participate in activities; opportunities exist for staff & families to learn from one another; volunteer opportunities match families' strengths, interests & skills.
- Community Resources & Family Support: families are connected to community resources; support and planning around transitions (to new classroom/group/program); educational & developmental resources are available to families.

## **Health and Well-Being:**

 The program completes a YoungStar approved nutrition and/or physical activity self-assessment tool.
 The program develops a Quality Improvement Plan (QIP) based on the results of the nutrition and physical activity self-assessment. Results can be incorporated into the program's overall QIP.
 If the program has met this requirement in the past, they must demonstrate progress on at least one nutrition/physical activity goal from the previous QIP.
 If the program allows meals, snacks or beverages to be brought from home, it has a policy that states the program will supplement the meals, snacks and beverages if they do not meet the guidelines established by the Child and Adult Food Care Program (CAFP).
